

RESOLUTION NO. 3626-2013

RESOLUTION OF THE FORT BRAGG CITY COUNCIL APPROVING C. V. STARR COMMUNITY CENTER FY 2013/14 FACILITY RENTAL FEE SCHEDULE

WHEREAS, on June 24, 2013, the Fort Bragg City Council adopted the FY 2013/14 C. V. Starr Community Center (the "Center") Budget; and

WHEREAS, the City has entered into an Operating Agreement with the Mendocino Coast Recreation and Park District for the operation and management of the Center to provide recreational services and activities for the health and welfare of City residents and others in the Mendocino coast region; and

WHEREAS, the Fort Bragg City Council has the authority to establish fees for use and services provided at the Center in accordance with Government Code Section 50402 and Section 8.1 of the Operating Agreement; and

WHEREAS, on April 25, 2013, the Council conducted a FY 2013/14 Budget Workshop with the Mendocino Coast Recreation and Park District Board to review the Proposed FY 2013/14 Center Budget; and

WHEREAS, as a result of the Budget Workshop process, it was determined that certain adjustments to the FY 2013/14 Facility Rental Fee Schedule are necessary; and

WHEREAS, the adjustments to the Facility Rental Fees were considered in the preparation and adoption of the Center's budget; and

WHEREAS, the amendments are identified on Exhibit "A" attached hereto; and

WHEREAS, based on all the evidence presented, the City Council finds as follows:

1. The fees are not a source of additional general fund revenues nor are they a "special tax" as described in California Government Code section 50076; and
2. The FY 2013/14 Budget of the C. V. Starr Community Center includes the changes presented in the Facility Rental Fees for FY 2013/14.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Fort Bragg does hereby adopt the FY 2013/14 C. V. Starr Community Center Facility Rental Fee Schedule as presented in Exhibit "A".

The above and foregoing Resolution was introduced by Councilmember Kraut, seconded by Councilmember Courtney, and passed and adopted at a regular meeting of the City Council of the City of Fort Bragg held on the 24th day of June, 2013, by the following vote:



	Rental Fees
MULTI-PURPOSE ROOM RENTALS - Rentals are subject to availability and approval from the C.V. Starr Director. Rentals do not include access to other areas within the Center. Day = 8 hrs	
Small multi-purpose room (Rm 1 or 2)	\$35/hr \$160/day
Combined multi-purpose room (Rm 1 + 2)	\$60/hr \$250/day
Aerobics Studio/Spin Room	Please call for the current rates
SWIMMING PARTY - Fee includes swim passes and use of party room or sundeck/BBQ area for 2 hrs. At least one adult chaperone is required per 10 participants or fraction thereof. Chaperones are included in the total head count.	
Up to 15 people total	\$125
Each additional person (25 max)	\$5
Up to 30 people total	\$225
Each additional person (50 max)	\$5
POOL & WATER PARK RENTAL - All rentals of aquatic facilities have a 2 hr minimum, are subject to availability, and must be reviewed and approved by the CV Starr Director at least 45 days in advance.	
All Aquatic Facilities	\$410/hr
Leisure/Activity Pool (no water park features)	\$110/hr
Water Slide & Lazy River	\$160/hr
Competition Pool	\$110/hr
Lane Rental (for local swim teams)	\$8/hr per lane
SPECIAL EVENT PERMIT FOR OUTDOOR FACILITIES	
Outdoor facilities are available for use from 8 AM to dusk. A special event permit is required for any event that is advertised and/or expected to have more than 20 participants on the premises for more than 2.5 hours. Fee will be waived for MCRPD and/or City-sponsored events.	
Special Event Fee	\$25/hr \$110/day

- * All facility rentals must be booked and paid at least 14 days in advance of the event.
 - * Refunds will NOT be given unless party or rental is cancelled at least 14 days in advance of event.
 - * Additional rental terms are stipulated in the Facility Use Agreement, which must be completed at time of booking.
 - * If available, multi-purpose room(s) will be free of charge for swim meets.
