

**RESOLUTION NO. 4248-2020**

**RESOLUTION OF THE FORT BRAGG CITY COUNCIL  
APPROVING PROFESSIONAL SERVICES AGREEMENT WITH LACO  
ASSOCIATES, TO PROVIDE DESIGN AND ENGINEERING SERVICES FOR  
THE PUDDING CREEK WATER MAIN RELOCATION PROJECT, CITY  
PROJECT NO. WTR-00014, AND AUTHORIZING CITY MANAGER TO  
EXECUTE CONTRACT (AMOUNT NOT TO EXCEED \$114,000.00; FROM  
WATER ENTERPRISE CAPITAL RESERVE FUND 615)**

**WHEREAS**, on February 10, 2020 City Council directed the Public Works Department to move forward with releasing a request for proposals to design improvements for the Pudding Creek Water Main Relocation Project; and

**WHEREAS**, on March 31, 2020, the City received two proposals for engineering design services for the Pudding Creek Water Main Relocation Project. Proposing firms included Coleman Engineering and LACO Associates; and

**WHEREAS**, those proposals were reviewed and evaluated on the basis of capabilities, qualifications, cost and responsiveness; and

**WHEREAS**, funds in the amount of \$210,000 were appropriated in the FY 2019/2020 budget for this activity, and sufficient funds are available for this contract; and

**WHEREAS**, based on all the evidence presented, the City Council finds as follows:

1. LACO Associates is qualified to provide necessary professional services to complete plans and specifications for the Pudding Creek Water Main Relocation Project.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Fort Bragg does hereby approve a Professional Services Agreement with LACO Associates for the Pudding Creek Water Main Replacement Project design and authorizes the City Manager to execute the same upon execution by Contractor (Amount Not to Exceed \$114,000.00 from Water Enterprise Capital Reserve Fund 615).
