RESOLUTION OF THE FORT BRAGG CITY COUNCIL ACCEPTING PUBLIC STORM DRAIN EASEMENTS FROM PROPERTY OWNERS ALONG THE MAPLE STREET STORM DRAIN PROJECT ALIGNMENT AND AUTHORIZING CITY MANAGER TO EXECUTE THE CERTIFICATES OF ACCEPTANCE

WHEREAS, there exists a storm drain pipe which traverses across several properties from its point of beginning on South Lincoln Street, conveying water in a westerly direction toward Park Street; and

WHEREAS, the City is required to obtain access to portions of privately owned property where public infrastructure exists in order to maintain utilities; and

WHEREAS, the storm drain pipe lying within these properties is part of the Maple Street Storm Drain Rehabilitation Project and will require removal and replacement of existing pipes (with the exception of 008-244-69 which was replaced in 2017) in the coming months; and

WHEREAS, the conveyance of the Public Storm Drain Easement will allow City and City Contractors to access, maintain, and improve the existing facilities now as part of the project and into perpetuity; and

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Fort Bragg does hereby:

- 1. Approve the conveyance of the following Public Storm Drain Easements:
 - a. A 10ft. storm drain easement at 401 Park Street, attached hereto as Att. 1 Grant Deed APN: 018-100-36; and
 - b. A 10ft. storm drain easement at 340 Park Street, attached hereto as Att. 2 Grant Deed APN: 008-244-31; and
 - c. A 5ft. storm drain easement at 315 S Lincoln Street, attached hereto as Att. 3 Grant Deed APN: 008-244-69.
- Authorize the City Manager to execute a Certificate of Acceptance for each easement and direct the City Clerk to send same to the Mendocino County Recorder's Office for recording.







Exhibit B Plat of Storm Drain Easement




