RESOLUTION OF THE FORT BRAGG MUNICIPAL IMPROVEMENT DISTRICT BOARD
APPROVING THE CITY OF FORT BRAGG FISCAL YEAR 2017/18 CAPITAL PROJECTS
BUDGET

WHEREAS, on May 18, 2018, the City Manager submitted to the City Council and the Fort Bragg Municipal Improvement District No. 1 Board, the Proposed City of Fort Bragg Capital Projects Budget for FY 2018/19; and

WHEREAS, on May 22, 2018, the City Council/District Board conducted a Budget workshop; and

WHEREAS, all projects in the City's Capital Improvement Program are subject to review by the Fort Bragg Planning Commission; and

WHEREAS, on June 6, 2018, the City Manager submitted to the City Council/District Board the City of Fort Bragg Capital Projects Budget for FY 2018/19; and

WHEREAS, based on all the evidence presented, the City Council/District Board finds that the FY 2018/19 Capital Projects Budget has been reviewed and adjusted as deemed appropriate by the City Council/District Board.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Fort Bragg and the Board of the Fort Bragg Municipal Improvement District No. 1 do hereby approve the FY 2018/19 Capital Projects Budget as submitted.



BE IT FURTHER RESOLVED that copies of the FY 2018/19 Capital Projects Budget are on file in the offices of the City Clerk and City Finance Director/Treasurer, and shall be considered a part of this Resolution.


