

RESOLUTION NO. 3861-2015

RESOLUTION OF THE FORT BRAGG CITY COUNCIL AMENDING THE C. V. STARR COMMUNITY CENTER FEE SCHEDULE TO INCLUDE COMPLIMENTARY FACILITY PASSES FOR LOW INCOME CHILDREN AND FOR MARKETING PURPOSES

WHEREAS, the C.V. Starr Community Center is a public facility serving residents and visitors of Fort Bragg and the Mendocino coast and its ongoing operation is consistent with the Council's goal of promoting healthy lifestyles through the provision of active recreational facilities; and;

WHEREAS, on June 23, 2014, the Fort Bragg City Council adopted the Fee Schedule for the C. V. Starr Community Center; and

WHEREAS, any free passes provided by the C. V. Starr Community Center must be a part of the Fee Schedule which needs to be approved by the City Council; and

WHEREAS, 50 free passes have existed in past Fee Schedules for marketing purposes and were not included in the most recently adopted Fee Schedule; and

WHEREAS, 300 free passes have been requested by the Mendocino Coast Children's Fund for use by low income children experiencing extreme hardship; and

WHEREAS, offering these free passes supports the Center's mission to "provide opportunities on the Mendocino Coast that promote physical and mental well-being for everyone, through active play, community enrichment, programs and events"; and

WHEREAS, the Board of Directors of the Mendocino Coast Recreation and Park District on October 21, 2015, by minute action, approved the proposed fee schedule adjustments; and

WHEREAS, the amended Fee Schedule is attached as Exhibit A hereto; and

WHEREAS, based on all the evidence presented, the City Council finds as follows:

1. Certain adjustments to the C. V. Starr Community Center Fee Schedule are necessary;
2. There is a sufficient need for the C.V. Starr Center to offer 300 free passes to low income children; and
3. There is a sufficient need for the C.V. Starr Center to have the ability to utilize 50 free passes for marketing and promotional purposes.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Fort Bragg does hereby amend the previously adopted C. V. Starr Community Center Fee Schedule to include 300 free passes for low income children and 50 free passes for marketing and promotional purposes.

The above and foregoing Resolution was introduced by Councilmember Peters, seconded by Councilmember Deitz, and passed and adopted at a regular meeting of the City Council of the City of Fort Bragg held on the 26th day of October, 2015, by the following vote:
