

RESOLUTION NO. 3786-2015

RESOLUTION OF THE FORT BRAGG CITY COUNCIL ACCEPTING BID OF AKEFF CONSTRUCTION SERVICES, INC. AS THE LOWEST RESPONSIVE BID, AWARDING THE CONTRACT FOR THE FORT BRAGG GREEN ALLEY PROJECT; CITY PROJECT NO. 2013-07 TO AKEFF CONSTRUCTION SERVICES, INC. AND AUTHORIZING CITY MANAGER TO EXECUTE CONTRACT (AMOUNT NOT TO EXCEED \$289,195.50; ACCOUNT NO. 409-5011-0731)

WHEREAS, the City of Fort Bragg was awarded a State Water Resources Control Board ("SWRCB") Proposition 84 Stormwater Grant for the Fort Bragg Green Alley Project; and

WHEREAS, in accordance with California Public Contract Code 20164 and other applicable laws, the project was advertised for bid on March 12, 2015 with bids due on March 24, 2015; and

WHEREAS, Addendum No. 1 was issued on March 16, 2015; and Addendum No. 2 was issued March 18, 2015; and

WHEREAS, five bids were received from qualified contractors with the apparent low bid coming from Akeff Construction Services, Inc. in the amount of \$287,995.50 for the base bid only; their bid with all alternates is \$289,195.50; and

WHEREAS, staff is satisfied that Akeff Construction Services, Inc. has the proper license, has the experience, and meets the requirements necessary to complete the project as bid; and

WHEREAS, the City Council has determined that the base bid plus alternate bid #1, are the appropriate scope of work for the Fort Bragg Green Alley project; and

WHEREAS, funds in the amount of \$643,379 are authorized through the SWRCB Prop 84 grant program for construction activities; and

WHEREAS, based on all the evidence presented, the City Council finds as follows:

1. Akeff Construction Services, Inc. bid meets the requirements of the Project bid documents and is considered responsive.
2. Sufficient funds are available through the SWRCB Prop 84 grant to fully construct the project as advertised and bid.
3. Akeff Construction has the proper license to complete the Project and based upon previous experience in completing similar projects is a responsible bidder.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Fort Bragg hereby accepts the bid of Fort Bragg Electric, Inc. as the lowest responsive bid, awarding the contract for the Fort Bragg Green Alley Project; City Project No. 2013-07 to Akeff Construction Services, Inc. and authorizes the City Manager to execute a contract which includes bid alternate #1, (Amount not to exceed \$289,195.50; Account No. 409-5011-0731).
