

## RESOLUTION NO. 3660-2013

### RESOLUTION OF THE FORT BRAGG CITY COUNCIL RECITING THE FACT OF THE SPECIAL ALL-MAIL BALLOT MUNICIPAL ELECTION HELD ON AUGUST 27, 2013, DECLARING THE RESULT AND SUCH OTHER MATTERS AS PROVIDED BY LAW

**WHEREAS**, a Special All-Mail Ballot Municipal Election was held and conducted in the City of Fort Bragg, California, on Tuesday, August 27, 2013, as required by law; and

**WHEREAS**, notice of election was given in time, form and manner as provided by law; election officers were appointed and, in all respects, the election was held and conducted and the votes were cast, received and canvassed and the returns made and declared in time, form and manner as required by the provisions of the Elections Code of California for the holding of elections in general law cities; and

**WHEREAS**, the Mendocino County Clerk-Recorder has canvassed the returns of the election and has certified the results to the City Council; and the results are received, attached and made a part hereof as Exhibit "A."

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Fort Bragg does hereby resolve, declare, determine and order as follows:

1. That the whole number of all-mail ballots cast in the City was 1,079.
2. That the measure voted upon at the election is as follows:

Shall the local Fort Bragg special purpose transactions and use tax (sales tax) of one-half of one percent for the express purpose of repairing, maintaining, and reconstructing existing streets, which expires on December 31, 2014, be extended until December 31, 2024 to allow for continued maintenance of streets and alleys in Fort Bragg? 3. That the number of votes given in the City for and against the measure were as listed in Exhibit "A" attached.


4. That the City Council does declare and determine that as a result of the election more than 2/3 of the voters voting on the measure related to the sales tax extension did vote in favor of it, and that the measure was carried, and shall be deemed adopted and ratified.

5. That the City Clerk shall enter on the records of the City Council of the City a statement of the results of the election showing: (1) the whole number of votes cast in the City; (2) the measure voted upon; and (3) the total number of votes given for and against the measure.

**The above and foregoing Resolution was introduced by Councilmember Kraut, seconded by Councilmember Hammerstrom, and passed and adopted at a regular meeting of**

the City Council of the City of Fort Bragg held on the 23<sup>rd</sup> day of September, 2013, by the following vote:


