NOTICE OF AVAILABILITY AND INTENT TO ADOPT INITIAL STUDY AND NEGATIVE DECLARATION

NOTICE IS HEREBY GIVEN that the City of Fort Bragg has a Draft Initial Study (IS) and Negative Declaration (ND), which is being distributed for public review, pursuant to the California Public Resources Code and the California Environmental Quality Act Guidelines (CEQA Guidelines).

PROJECT TITLE: An Ordinance Amending Title 18 of the Inland Land Use and Development Code Regulating Cannabis Businesses (Sections 18.22.030, 18.24.030, 18.42.055, 18.42.057, 18.42.059 and 18.100.020)

APPLICANT: City of Fort Bragg

PROJECT DESCRIPTION: The proposed project includes amendments to the Inland Land Use and Development Code to include new and revised land use regulations and permitting requirements for indoor commercial cannabis cultivation in the industrial zoning districts and to modify regulations for cannabis retail businesses in commercial zoning districts. The proposed changes would apply only to areas in the inland (non-coastal) area of Fort Bragg. The proposed ordinance does not change the zoning of any parcels within City limits and no physical development is proposed.

PROJECT LOCATION: Inland Industrial (Light and Heavy), Central Business District, General Commercial, and Highway Visitor Commercial
