NOTICE OF PENDING ACTION

NOTICE IS HEREBY GIVEN that the Community Development Director of the City of Fort Bragg has approved a Mobile Vending Permit for locations in the 300 and 400 blocks of North Franklin Street, including 411 N Franklin Street and 300 N Franklin Street, and fronting the vacant lot at the northeast corner of Franklin and Redwood Streets, and the 200-block of E Alder Street. Mobile vending on private property is not a part of this permit.

If they object to the approved locations, all property owners and business owners within 300 feet of the approved locations (below) can appeal the mobile vending permit to the Planning Commission for the Planning Commission's consideration. Absent an appeal, the Community Development Director's review authority shall be final on Thursday, December 14, 2023.

Appeal Process. Decisions of the Director shall be final unless appealed by an interested party to the Planning Commission within ten (10) days after the decision is rendered. An appeal shall be submitted in writing along with the appeal fee of \$375.00 to the Community Development Department and shall specifically state the pertinent facts and the basis for the appeal. Appeals shall be limited to where the Director's determinations of the meaning or applicability of the regulations are believed to be in error or an objection to the mobile vending location (See FBMC 10.20.150).
